An Interview with Brenda Ferraro, newly appointed  
Senior Director of Networks and

**"How does your relationship with NH-ISAC benefit your approach to motivating the health sector in the area of Third Party Risk?"**

I am fortunate to continue as the co-chair of the NH-ISAC Third Party Risk Governance workgroup, along with Peter Subar from J&J. Together we are leading the workgroup to bring forward the Third Party Risk Governance Summit (TPRG) in concordance with the upcoming NH-ISAC Fall Summit and will publish a white paper to share thought leadership on third party risk standards. With NH-ISAC relationships I've built over the years, the members have shown to be a strong family of practitioners all motivated to share information in support of an economic approach to health sector Third Party Risk.

**"Why should NH-ISAC members take advantage of this opportunity?"**

CYBERFIT's *Shared Risk Assessment* component enables members to focus on the economic approach to Third Party Risk Assessment by sharing assessments using the NH-ISAC CYBERFIT assessment repository (powered by Prevalent). Prevalent has built its software solution to remove delay and waste in the workflow and handoffs of content between the assessor and the assessed party. When third party assessments are shared and published in the repository, the membership has a greater opportunity to experience an increased value add realization. The cost savings of completing a single assessment and sharing with many allows the members to refocus their funding to solving the problems of tomorrow. Prevalent is targeting 1000 assessments by end of year and we are looking for all NH-ISAC members to take advantage of completing an assessment questionnaire for hands-on experience, awareness and value add benefit for the entire NH-ISAC community.

## Security Operations Services

### Informational Webinar

On September 6, 2017, SecureWorks and Amgen jointly presented a webinar on CYBERFIT *Security Operations Services* to NH-ISAC members.

SecureWorks opened the discussion with highlights of current threats including ransomware, observing that 88% of ransomware attacks have occurred in health care organizations. Suggestions were made on how to assess a company's security posture, and when to use the different CYBERFIT offerings of vulnerability assessment, penetration testing, web application testing, and incident response.

Amgen followed with an overview of security services and the Gartner magic quadrant's high-level view of market leaders such as SecureWorks. It was also recommended to identify integration between NH-ISAC's CYBERFIT offerings and other member services that may be useful to an organization, such as threat intelligence information.
