## What is CYBERFIT?

**CYBERFIT** is a group of added security services offered by the NH-ISAC focused on reducing cyber security risks within the healthcare community.

**CYBERFIT** provides organizations with affordable access to shared data and enhanced security services to help them evaluate their cyber security posture. Services include access to a unique repository of third party risk assessments, and provide penetration testing, vulnerability scanning, perimeter monitoring and incident/malware analysis.

**CYBERFIT** helps organizations gauge their risk tolerance among peers and map a path toward managing and monitoring their internal and third party vendor risk.
